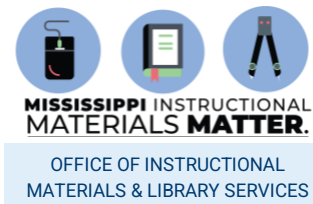

#### Program Strengths

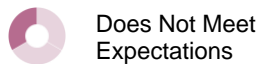
- The pacing and layout of the textbook allow for a coherent flow.

- There is insufficient practice and remediation for students that are not performing on or above grade level.



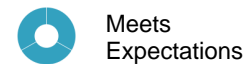
